WHAT?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> • Social Security Number and income • Account balances and payment history • Credit history and credit score <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>

HOW?	All financial companies need to share customers' personal information to run their everyday business. How does Cooperativa de Ahorro y Crédito de la Federación de Maestros de Puerto Rico (FedeCoop) protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Cooperativa de Ahorro y Crédito de la Federación de Maestros de Puerto Rico (FedeCoop) collect my personal information?	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> • Open an account or deposit money , or • Apply for a loan, or • Use your credit or debit card, or • Send a wire transfer, or show an ID Card issued by your state. <p>We also collect your personal information from others, such as credit bureaus.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> • Sharing for affiliates everyday business purposes-information about your creditworthiness • Affiliates from using your information to market to you • Sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>

DEFINITIONS

Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • Cooperativa de Ahorro y Crédito de la Federación de Maestros de Puerto Rico (FedeCoop), does not have affiliates.
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • Cooperativa de Ahorro y Crédito de la Federación de Maestros de Puerto Rico (FedeCoop) does not have Nonaffiliates.
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> • Cooperativa de Ahorro y Crédito de la Federación de Maestros de Puerto Rico (FedeCoop), does not have Joint marketing.
